## A. THE COMMISSION

Based on the Agreement between the Government of the Slovak Republic and the Government of the United States of America concerning the J. William Fulbright Commission for Educational Exchange in the Slovak Republic (198/2005 Coll. as amended), the Commission is responsible for administering and supervising the Fulbright Program in the Slovak Republic.

The Commission strives to:

- support outstanding individuals in both countries who can extend expertise in their field of specialization;
- engage leading U.S. and Slovak scholars, students and professionals in educational and research exchanges and to develop mutual relationship and cooperation;
- increase expertise in fields in which lecturing and/or research is conducted in both countries;
- extend activities to establish and support cost sharing programs with participating institutions;
- serve as an advising center for individuals and institutions that provides accurate and up-todate information about study and research opportunities in the U.S.

The bi-national **Board of the Commission** oversees the operation and activities of the Commission. The Minister of Education, Science, Research and Sport of the Slovak Republic appoints Slovak Board members and the U.S. Ambassador to the Slovak Republic appoints American Board members. Both serve as Honorary Chairmen of the Board.

The Board has the responsibility for setting long term goals and priorities of the program, program activities, selection and nomination of grantees, and coordination of finances of the Commission.

# B. FULBRIGHT AWARDS

The Commission administers and supervises a variety of high-profile award programs for U.S. and Slovak citizens based on an open, merit-based competition. The Commission takes into account recommendations of selection committees focusing on professional skills, academic achievement, promising career development, financial means available, and other program requirements; and announces the final nomination of Fulbright grantees.

The academic year 2020-21 continued to be heavily affected by the Covid -19 pandemic. Commissions were requested by the Bureau of Educational and Cultural Affairs – State Department (ECA) to assess the situation in their countries in regard to the COVID-19 pandemic and to inform the ECA by November 15, 2020 which of their programs will be open for in-person or hybrid participation in the academic year 2020-21.

The Commission contacted all Slovak and U.S. grantees and the host institutions where ETAs were supposed to be placed to find out whether there was a possibility for in-person or hybrid participation after January 2021. The Board was also properly informed about the ECA guidance/pathways, both for U.S. Students/Scholars and Visiting Students/Scholars, and on the status of the grantees. After thorough assessment of the information available, especially the status of the host institutions in Slovakia and the U.S., and the epidemiological situation in Slovakia, the Board decided:

- <u>to defer the English Teaching Assistant Program (ETA)</u> the Board concluded that the program was not feasible and ETAs were offered a deferral to September 2021.
- to move forward with other Fulbright Programs depending on the status of the host institutions, grantees who could not carry out their grant in-person were offered a deferral to the academic year 2021-22.

Due to the global suspension of the Fulbright Program and in-person requirement for all Fulbright grants, only two Slovak grantees were able to travel and pursue their grant in the academic year 2020-21. Those who were not able to do so were deferred to the academic year 2021-22. Above mentioned resulted in the reduction of number of grantees selected for the academic year 2021-22.

## 1. Fulbright Student Program

Slovak and U.S. graduate students can apply for up to 9-month scholarships for independent research or study at Slovak or U.S. institutions, respectively. Candidates are required to prove an outstanding university record and to submit high-quality and well-conceived projects.

**Slovak applicants** may conduct independent research, and if funding is available, enroll in Master's programs. They can apply in any field except for clinical medicine, M.BA and LL.M. Candidates without prior extensive U.S. study experience are given preference.

**U.S. applicants** can pursue individual research projects under tutorial of a Slovak expert in the respective field. Knowledge of Slovak language is desirable for commensurate with the level needed in fields like political science, history, linguistics, and anthropology.



## **Slovak Students:**

- **Katarína Jurišová** was originally deferred to AY 21-22. She declined the award in June 2021 because she was offered an assignment with the Permanent Representation of the Slovak Republic at the EU in Brussels, Belgium.

The Commission did not have any U.S. grantees in the Fulbright Student Program.

## 2. Fulbright Scholar Program

**U.S. scholars** with comprehensive experience propose projects on research or lecturing at Slovak institutions. The applications are welcomed in any field; although preference may be given to the needs of Slovak academic institutions. Candidates without extensive research or lecturing experience in the Slovak Republic are given preference.

**Slovak scholars** who hold a PhD. degree (in arts and some other fields comparable professional experience is required) must include an invitation letter from the U.S. institution in their application. All areas of research or lecturing, except clinical medicine, are eligible. Candidates without prior extensive U.S. research or study experience are given preference.

**U.S. Scholars - Jeffrey Elton Anderson, Gretchen Frances Bennett, Larry Alan di Matteo, Charles Arthur Martin De Bartolome,** and **Michael Joseph Murphy** were deferred to the academic year 2021-22.

**Slovak Scholars** - **Daniela MERESSA RUSNOKOVÁ, Pavol MUDROŇ, Štefan TKÁČ** were deferred to the academic year 2021-22.

Only two SK Scholars - Katarína MARÁKOVÁ and Kamila URBAN successfully completed their grant.

# 3. English Teaching Assistant (ETA) Program

The Slovak secondary schools receive assistance in strengthening English language instructions by establishing a qualified native speaker presence. At the same time, U.S. participants gain from intensive cross-cultural interaction and research opportunities.

Due to the pandemic, the wholeETA program in Slovakia was deferred to the academic year 2021-22.

NOTE: Lillie Laura Alsky declined the award in December 2020. Three ETAs were newly selected to complement the cohort 2021-22 due to the funding available – Colleen Mary Gair, Corey Danyal Khan, Evelyn Adrienne Berryhill.

4. Fulbright Specialist Program

Slovak academic institutions can invite a U.S. expert for 2 - 6 weeks to lecture, assist in developing curricula and educational materials, participate or lead seminars or workshops, assist in faculty development, etc. The selection and placement must be completed within 3 months.

The program is a short-term complement to the traditional Fulbright Scholar Program. It attracts those U.S. experts who otherwise would not be able to participate in one or two-semester programs.

Due to the ongoing pandemic, the Fulbright Specialist Program has been suspended.

#### 5. Fulbright Scholar-in-Residence Program

Scholar-In-Residence Program assists U.S. higher education institutions in expanding academic exchange programs. By supporting non-U.S. Scholars through grants for teaching at institutions with no strong international component, both the U.S. institution and the scholar grantee benefit.

The Commission did not have any scholar-in-residence fellows.

## C. OTHER AWARDS

#### 1. Hubert H. Humphrey Fellowship Program

The program gives the opportunity to mid-career professionals to participate in 10-month study and related professional experience at U.S. institutions in fields such as environmental management, finances, human resources management, urban planning, communications, drug abuse education, etc. Final selection of nominees from over 150 countries is made at the U.S. State Department:

Ms. Danihelová had the opportunity to gain knowledge about economic development and non-profit organizations through on-line classes she attended from January till May. After the theoretical part of the program, she started a 6-week long internship with the Allen Neighborhood Center in Lansing, Michigan which gives support to the local community. As a communication expert, she helped the organization to set communication activities for the upcoming period and established effective communication channels which helped the center to be acknowledged not only by the local community but the public as well.

## 2. Study of the U.S. Institutes (SUSIs)

The Study of the U.S. Institutes are 5-week programs focusing on American Studies and civic society affairs. The candidates are selected through worldwide competition.

The Study of the U.S. Institutes for summer 2021 were organized in a hybrid format. In July 2021, the selected candidates for Slovakia participated in online courses and lectures. The in-person component is scheduled for Spring 2022.

- 3. Inter-Country Travel Program

Inter-Country Travel Program provides Slovak Institutions with an opportunity to seek funding for travel expenses to invite U.S. Fulbright Grantees from other countries in Europe to lecture in Slovakia.

Due to the ongoing pandemic, no inter-country travels were requested.

#### 4. Cybersecurity Program

Fulbright Poland together with Fulbright Commissions in Bulgaria, Czech Republic, Hungary, Romania and Slovakia as well as partners from the U.S. organized a cybersecurity exchange program. The visit, designed for university representatives, was carried out in a hybrid form – combining virtual meetings with a planned in-person visit to the U.S. East Coast at a later time. Two Slovak candidates were accepted and participated in an on-line part of the program from March 10 to June 23, 2021 – **Mr. Boris Bučko** - Žilinská Univerzita v Žiline, Faculty of Management Science and Informatics, Department of Mathematical Methods and Operations Research, and **Ms. Soňa Sopúchová** - Comenius University, Faculty of Law, Institute of Information Technology Law and Intellectual Property Law. The in-person part is planned for Spring 2022.



## D. GRANT SUPPORTING ACTIVITIES

Due to the suspension of the program and the fact that there were no U.S. grantees in Slovakia present in the academic year 2020-21, in-person activities or on-site visits could not be carried out. The focus of the Commission activities shifted to the virtual sphere entirely.

## 1. Pre -Departure Orientation Seminar

The seminar is mandatory for all outgoing Slovak grantees in order to brief them on important issues related to their departure for the U.S. and the successful completion of their grant.

Due to the COVID-19 restrictions, both seminars for Slovak grantees were held online - **December 3, 2020/ May 19, 2021**. The PDO's main agenda included terms and conditions of the Fulbright and Humphrey awards, visa applications, health insurance, and financial aspects of the awards. Representatives of the U.S. Embassy Bratislava, Mr. David Duerden and Ms. Emily Teickenson, participated in the orientation and shared with current grantees up-to-date information on the pandemic situation in the U.S. and provided insights on the U.S. Some of the Fulbright alumni also joined the orientation and shared their practical experience with current grantees.

## 2. Orientation Seminar

The seminar is mandatory for all incoming U.S. grantees in order to brief them on important issues related to their stay in Slovakia.

The orientation seminar took place **from 20 to 24 September, 2021 in-person**, since the situation related to COVID -19 pandemic allowed for an in-person form. Guidelines of state health authorities and the legislation in place were observed. The seminar was organized in order to familiarize U.S. grantees with Slovak history, culture, politics, economy, education etc. Furthermore, a review of the terms and conditions of their grant, financial, visa, and health issues were an essential part of the orientation. A crash course on Slovak language has proven to be of importance to U.S. grantees. The Commission annually reviews and updates the program in order to implement the guidance and protocol for a variety of possible crisis situations, diversity & equity & inclusion or any other emerging issues. Due to the covid restrictions, networking activities were limited to participants of the seminar only.







#### 3. The Annual Mid-Year Conference

The mid-year conference remains one of the Commission's core activities for U.S. grantees to exchange experiences, present their goals and achievements, and discuss both professional and personal issues. The conference is a valuable resource of different perspectives on academic exchanges for the Commission and the Board that can help the Commission to adopt necessary changes and/or improve the administration of the program.

Due to the ongoing pandemic, the mid-year conference could not be organized.

#### E. OUTREACH ACTIVITIES

The core outreach and recruitment activities to attract prospective candidates of Fulbright awards shifted to the virtual sphere entirely. For this purpose social media and Zoom platform were utilized.

Social media – Instagram, Facebook and LinkedIn (launched on August 1, 2021) – are crucial in communication with the interested audience. The Commission is continuously working and improving communication strategy. Social media increased posts focusing on the Commission activities and alumni impact, i.e. Alumni Spotlight Series. The Commission's web page remains the primary source and administrative tool for information and guidance on the Fulbright Program's opportunities and other scholarships. The Commission is in the final stage of the preparation of a new website. The staff was working intensively on a completely new visual and content of the website to offer the audience a more detailed, comprehensive and up-to-date information on the Fulbright programs.

In order to improve our presence in social media, **Ms. Natalie Gilbert (University of Michigan**) has joined the Commission as Communication and Social Media virtual intern for 6 weeks (May 17 – June 28, 2021).



The Commission activities were as follows:

- **Fulbright Visiting Scholar Program** September 9, 2021 a Zoom webinar focused on Fulbright Visiting Scholar program followed by a Q&A session with program alumni Ms. Aneta Bobenič Hintošová and Ms. Alžbeta Brozmanová Gregorová.
- EDAMBA International Scientific Conference for Doctoral Students and Post-Doctoral Scholars October 27, 2020 online presentation of Fulbright scholarships to doctoral students at University of Economics in Bratislava. The presentation was focused on Fulbright programs for PhD. and post-doctoral students and young researchers and their home institutions.
- International Education Week (November 16 20, 2020)
- on the occasion of celebrating the IEW 2020, EducationUSA Slovakia prepared several activities. On November 19, the center held a webinar on U.S. Higher Education and Holistic Admissions, in cooperation with New York University Abu Dhabi. The webinar explained and described in details admission procedures of U.S. universities
- EducationUSA prepared a quiz on U.S. education for Instagram followers. There were three winners who got a package of EducationUSA swag
- Short videos on 5 steps that, originally recorded in the previous year in collaboration with American Spaces in Slovakia, were shared on Facebook and two short Powtoon promo videos about our services for Slovak students were created.
- Admission Essays Webinar February 26, 2021 EducationUSA Slovakia was invited to hold a virtual presentation on the topic "Admission Essay" for students of BESST, a private Slovak-English bilingual high school. The presentation was part of the "Day of Opportunity" event organized by mentioned school to help navigate high schoolers through study and job opportunities after their graduation. The webinar focused on personal essays.
- Fulbright Program and EducationUSA presentation in **The Slovak Spectator (February 2021)**-visual presentation (advertisement) of Fulbright Program opportunities and EducationUSA services printed in Slovak Spectator Vol. 27, No.2, edition focused on education and universities. The pdf version was sent to Slovak Spectator's list of English teachers.
- What Makes a Good Essay (webinar, March 24, 2021) EducationUSA Slovakia joined FLEX Alumni in Slovakia in their essay writing contest and with NYU Abu Dhabi organized an online webinar "What Makes a Good Essay". It was attended by 74 (out of 95 registered) high school students. Ms. Zita Kassai from NYU Abu Dhabi explained how to write a good narrative statement and what are its key elements. Her presentation was followed by a group exercise and a lively discussion with the audience. The webinar officially kicked off the essay writing contest *The story with a thousand faces* organized by FLEX alumni in Slovakia with the support of the U.S. Embassy Bratislava small grant and Fulbright Slovakia/EducationUSA Slovakia. There were 26 essays submitted.
- **2021 EAIE Online Conference (September 28 October 1, 2021)** EducationUSA Adviser Zuzana Kopčanová attended EAIE's Community Exchange Conference. It was a virtual event with more than 70 hours of live, as well as on-demand content for participants to explore. The event



offered content on a variety of topics connected with international education within the European context.

## 4. 75<sup>th</sup> Anniversary of the Fulbright Program

On the occasion of the 75<sup>th</sup> anniversary of the Fulbright Program worldwide the Commission organized several activities:

• The Commission launched the **LinkedIn profile** on August 1, 2021 in addition to Facebook and Instagram, and started the **Alumni Spotlight Series** celebrating 75 years of the impact

5. ADVISING ACTIVITIES



EducationUSA Center by Fulbright Slovakia is part of a worldwide advising network called EducationUSA. It is the official authority on providing information on educational opportunities in the U.S., sponsored by the U.S. Department of State.

Educational advising is an essential part of Commision's activities. The mission of the EducationUSA Advising Center is to provide accurate, comprehensive, current and unbiased information about study opportunities for those students who would like to pursue their higher education at accredited postsecondary institutions in the United States. The advising center provides free-of-charge services for those who wish to pursue their postsecondary education in the U.S. through speaking engagements, participation in educational fairs, and contact with competent high school and university staff. Due to the COVID-19 pandemic, advising and outreach activities have been conducted only virtually, using either Skype or Zoom platform.

The Commission's Advising Center actively cooperates with local American Spaces, located in Košice and Banská Bystrica. Both American Spaces are included in the official EducationUSA network and provide basic reference advising services.

#### G. ADMINISTRATION/STAFF AND FUNDING

**Funding:** The respective fiscal year of the Fulbright Commission is observed as set by U.S. (October 1 – September 30) and Slovak (January 1 – December 31) regulations. The financial income is composed of two sources of funding: allocation from the U.S. Government and allocation from the Slovak Government.

In-kind contributions to the Commission include tuition waivers, donated office space, air-tickets, funds allocated to other programs through other U.S. or Slovak government activities, health insurance for the grantees, private in-kind sponsorship etc.



The Commission is subject to an independent audit of receipts and disbursements and on the internal control structure on an annual basis. The Slovak Ministry of Education, Science, Research and Sport audits the expenses from the Slovak government contribution separately.

**Administration:** Lýdia Tobiášová informed the Board on the notification of the Ministry of Interior of the Slovak Republic, by letter of November 18, 2020 on the approval of the new Statute of the J. William Fulbright Commission for Educational Exchange in the Slovak Republic (approved on the 57th Board meeting), in accordance with Section 6a para. 3 of the Act No. 116/1985 Coll. on activities of organizations having an international element in the Czechoslovak socialist republic. The Ministry of Interior of the Slovak Republic notified the Commission, by letter of December 3, 2020 that the Ministry of Interior took note of the change.
